\*Travel and subsistence repayments are made to reimburse actual expenditure for travel, meals and overnight accommodation unavoidably incurred as part of a councillor's or co-opted member's duties. Mileage is repaid at 40 pence per mile for the first 10,000 miles and 25 pence thereafter.

The Council's allowances are recommended by an Independent Remuneration Panel. As a result, the Oxfordshire County Council's allowances reflect the Panel's view that 40% of a councillor's time is deemed to be voluntary.
